
Subject: Regarding issue of no Objection certificate to Guru Amardass Adarsh Institute,

2. On consideration the documents with affidavit, presented/ given by your School Management, and thoroughly considering the recommendation of District Education Officer (S.E.) Tarn-Taran and Director, Education department, (S.E.) Punjab, The required No Objection Certificate is hereby issued on the following terms and conditions:-
 1. If in future, on getting any complaint or on inspection, if the fact comes in knowledge that while getting the No Objection Certificate from govt. the wrong information was provided or if you do not abide by the instructions, issued from time to time by the Government of Punjab, and in such way, if the conditions of affidavit are not abided then in that case the No Objection Certificate can be taken back at any time.
 2. It will be compulsory in your school to give education of Punjabi up to tenth standard and CBSE, New Delhi, which is compulsory makes efforts for getting the examination of Punjabi of such schools and it is also mentioned here that in case of non implementation of the same, the No Objection Certificate will be taken back from immediate effects.
 3. After getting affiliation from CBSE, New Delhi, the school management will be bound to give salary and other allowance to the Teaching and non teaching staff like other government employee and in case of non-implementation of the same the No Objection Certificate will be taken back.
 4. You, yourself and your management will make it sure, that when your District's District Education Officer or from any Senior Officer of Education Department, any information is required, you will provide such information and the necessary co-operation will be given.
